Any transactions made outside of the United States will appear in U.S. Dollars at the exchange rate on the day in which the transaction was posted to your account.

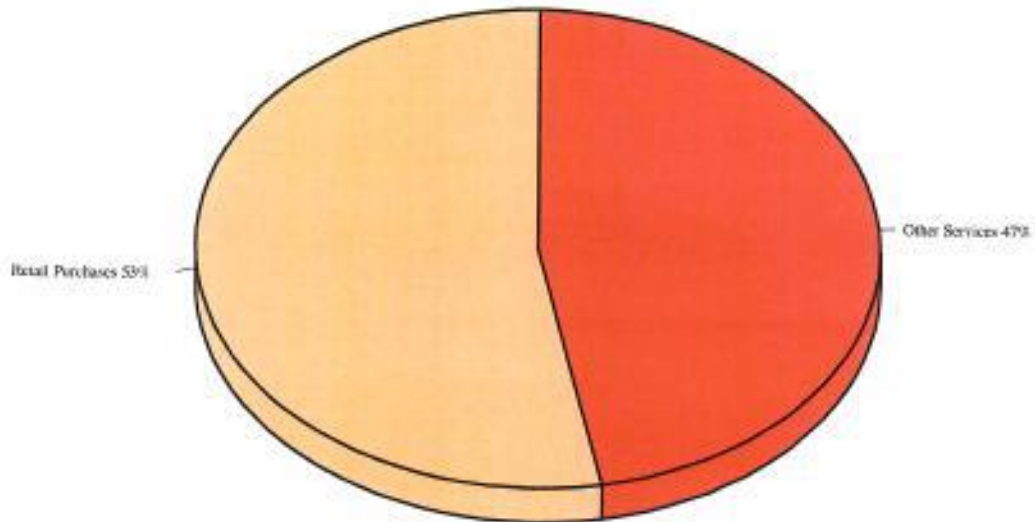

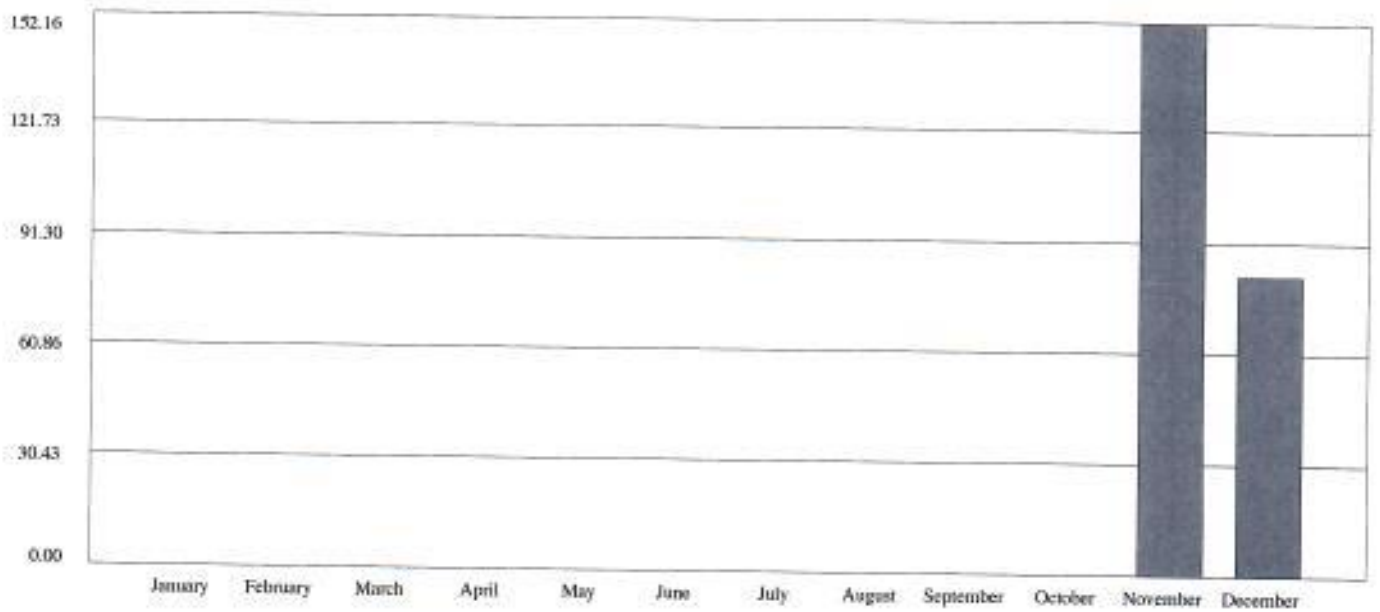
